


In a major shift in trade policy, United States President Donald Trump on Thursday, July 31, signed an executive order significantly reducing reciprocal tariffs for several African countries, including Lesotho. Under the order titled "Further Modifying the Reciprocal Tariff Rates," tariffs on goods.

Due to its membership in SACU, Lesotho applies the SACU common external tariff. South Africa generally sets the tariff schedule for SACU in consultation with SACU members; although SACU has been working to establish a tariff board, tariff rates fall mostly within eight levels ranging from 0 to 30.

Under the order titled "Further Modifying the Reciprocal Tariff Rates," tariffs on goods from Lesotho have been slashed from 50 percent to 15 percent—a move expected to ease trade tensions and stimulate exports.
